Summary of changes – existing v. emerging policies (1)

- Local character and design: largely retaining existing approaches; more emphasis on Village Planning; new policies on local environmental impacts (incl. air quality) and basements
- Green Infrastructure: retaining existing approaches to protecting MOL, Green Belt and OOLTI; strengthened tree policy; more emphasis on green walls; consolidating policies on rivers but retaining existing approaches





 Climate change & sustainable design: consolidated policies but retaining existing approaches; updated flood risk policy (also in relation to basements); new policy on waste management in development sites





Summary of changes – existing v. emerging policies (2)

- Town centres: consolidated policies; retaining existing approaches; reflecting locally distinctive Village Planning Guidance SPDs; Article 4 Direction
- Community facilities: consolidated policies; more emphasis on marketing for alternative uses; strengthened education and health & wellbeing policies (incl. restrictions on hot food takeaways near schools); new telecommunications policy
- Housing: updated to reflect current housing target and local needs; robust approach to viability; consolidated approach to loss of housing, infill, backland and backgarden development








Summary of changes – existing v. emerging policies (3)

- Employment: strengthened approach to employment land; new policy on loss of offices; new designation of key office areas; new policy on the protection of industrial land and business parks; robust approach to marketing requirements; 2 x Article 4 Directions
- Transport: consolidated policies but retaining existing approaches to facilitating sustainable travel choices; updated policy to ensure appropriate parking standards and servicing arrangements are provided, including emphasis on electric vehicle charging points









Summary of changes – site allocations

- Local Plan focus on strategic sites those that contribute to delivering the policies and spatial strategy
- Need to ensure there is sufficient land identified for employment, retail, housing and social infrastructure
- Allocate key sites for certain uses where development / regeneration is anticipated to take place within the next 15 years

Exercise 1

- LP 41 and 42 Offices / Industrial Land and Business Parks
 - Do the policies strike the right balance between protecting employment land and allowing some redevelopment? What about existing employment sites in residential areas? Should we allow for more mixed use schemes on such sites?
- LP 22 Sustainable Design and Construction
 - Should the policy be strengthened in relation to 'zero carbon'?
 - What if developments could not achieve 'zero carbon' would it lead to implications for overall viability, such as on affordable housing contributions?
