

Based on information from the Richmond Carers Centre a greater proportion of young carers are from ethnic minority groups than the average for all carers within the borough (29% of young carers compared to 13% of all carers identified by the 2011 census).

The 2014 Richmond Young People's Survey showed that 11% of pupils in year 5, 6 and 7, and 7% of pupils in year 8 and 10, reported that they care for someone at home on a regular basis who is unable to care for themselves. Only 1% felt this often stopped them from taking part in recreational activities, and 3% felt it sometimes stopped them. The Knife Crime Prevention Programme (KCPP) is an intervention which aims to reduce the prevalence of knife carrying and use by young people. Young people are referred to the programme if they are aged between 10 and 17 and have been convicted of an offence where a knife or the threat of a knife is a feature. Under <u>section 184</u>, if a housing authority has reason to believe that a person applying to the housing authority for accommodation, or assistance in obtaining accommodation, may be homeless or threatened with homelessness, it must make inquiries to satisfy itself whether the applicant is eligible for assistance and if so, what duties are owed to that person.
- 2. It should be noted that the presence of children within a household presenting as homeless will accord that household an automatic priority need.

3. 16% of the positive decisions received by families with children were instances where homelessness was prevented.
