

# **Key messages from past consultations**

#### Barefoot Consultation (2010):

• 27% of residents wanted to see improved river links

#### All in One consultation (2010):

- 88% of respondents in Twickenham said that they were very satisfied with their local area as a place to live
- When commenting on what they liked best about the area, the river was second only to parks and open spaces in popularity

#### Twickenham Area Action Plan (2013):

 The plan highlighted that any development of the site should maintain the Embankment as a working quay, and subject to feasibility, provide mooring and landing facilities



# Feedback from pop-up shop

Approximately 800 people visited the pop-up shop on Church Street. Out of the 334 comment cards received, 83 of the responses were on the topic of connectivity to and use of the River. Snapshot of views below – consultation closes on 16<sup>th</sup> September.

#### Connectivity

- Bridge across the River
- An open River vista
- Improved pedestrian access
- Community spaces to bring people into the area

#### **Use of the River**

- Passenger ferries and a landing stage
- Boating opportunities





# **Topic based issues**

- Key objective: to link the town centre to the River
- We particularly want to draw people from King St onto the Embankment and into Diamond Jubilee Gardens
- Physical aspects of connectivity (i.e. River vista) to be covered as part of the Configuration of the Site workshop
