The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended by the Local Government Act 1985(b), the New Roads and Street Works Act 1991(c), the Traffic Management Act 2004(d) ("the Act of 2004") and all other enabling powers hereby make the following Order—

PART I PRELIMINARY

Commencement and Citation

1. This Order shall come into operation on 28 July 2008 and may be cited as the London Borough of Richmond upon Thames (Free Parking Places) (Limited Time) (Consolidation No. 1) Order 2008.

Revocation

2. Without prejudice to the validity of anything dome or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Free Parking Places) (Short Stay) Order 1997(e), as amended, is hereby revoked.

Interpretation

3. (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"civil enforcement officer" means a person appointed by or on behalf of the Council for the enforcement of road traffic contraventions;

"Council" means the Council of the London Borough of Richmond upon Thames;

"disabled person's badge" and "disabled person" have the same meanings as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000(f);

"disabled person's vehicle" means a vehicle which displays in the relevant position a disabled person's badge;

"driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;

"enactment" means any enactment, whether public general or local, and includes any order, by-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"goods" means goods of any kind whether animate or inanimate and includes postal packets of any description; and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection:

"goods carrying vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description, and not drawing a trailer;

"motor cycle" and "invalid carriage" have the same meanings respectively as in Section 136 of the Road Traffic Regulation Act 1984;

"one-way street" means a highway in which the driving of vehicles otherwise than in one direction is prohibited;

"owner" in relation to a vehicle means the person by whom such vehicle is kept and used;

"parking place" means any area on a highway designated as a parking place by this Order;

"parking space" means a space in a parking place referred to in any of the Schedules which is provided for the leaving of vehicles;

"passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed or adapted solely for the carriage of not more than twelve passengers (exclusive of the driver) and their effects and not drawing a trailer;

"penalty charge" means the charge set by the Council under the provisions of the Road Traffic Act 1991(c) or the Act of 2004 and following approval of the Secretary of State or the Mayor of London, as the case may be, which is to be paid to the Council following the issue of a penalty charge notice and within 28 days of the issue of that notice:

"permitted hours", in relation to a parking place, means the period specified at the beginning of the Schedule relating to that parking place;

"reduced penalty charge" means the charge set by the Council under the provisions of the Road Traffic Act 1991 or the Act of 2004 and following approval of the Secretary of State or the Mayor of London, as the case may be, which is to be paid following the issue of a penalty charge notice within 14 or 21 days of the issue of that notice;

"Schedule", when followed by a number means the schedule to this order so numbered;

"Schedules", so far as the context permits, means Schedule 1, Schedule 2, Schedule 3, Schedule 4, Schedule 5, Schedule 6, Schedule 7, Schedule 8, Schedule 9, Schedule 10, Schedule 11, Schedule 12, Schedule 13 or Schedule 14;

"telecommunications system" has the same meaning as in the Telecommunications Act 1984 (a);

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) For the purposes of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position when it is so regarded for the purposes of Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000(b).

PART II DESIGNATION OF PARKING PLACES

Designation of Parking Places

4. Each area on a highway comprising the length of carriageway of a street specified in column 2 of the Schedules and, unless otherwise so specified, bounded on one side of that length by the edge of the carriageway and having a width throughout of 1.83 metres is designated as a parking place.

Number and situation of parking spaces

5. The number of parking spaces in each parking place referred to in column 2 of the Schedules shall not be less than the number specified in relation thereto in column 3 of those Schedules and the number and situation of such parking spaces in each parking place shall be as may be determined by the Council:

Provided that where a figure is specified in column 4 of the said Schedules in relation to any parking place referred to in column 2 of the said Schedules there shall at all times be a part or parts of the said parking place of a total length in metres not less than that figure and of a width equal to the width of the said parking place in which there shall be no parking bay or part of a parking bay or, as the case may be, in which there shall be no parking space or part of a parking space.

Vehicles for which parking places are designated

6. Each parking place referred to in the Schedules may be used, subject to the provisions of this Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles, motor cycles or invalid carriages.

Limited time of waiting and contraventions in parking places

7. If, during the permitted hours, a vehicle is left in a parking place designated in a schedule whose number is given in column 2 of an item in the following table for a continuous period of more than the limited time specified in column 3 of that item or without complying with any other requirement of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice may then be issued by a civil enforcement officer or served by the Council.

Manner of payment of the penalty charge

- 8. The penalty charge shall be paid to the Council by cash, cheque, postal order or other accepted means which shall be delivered or sent by post to the Council's Payment Office or to the Council's agents at the address or addresses indicated on the penalty charge notice and in accordance with instructions on that notice, to arrive no later than 5pm, or be paid by an approved credit/debit card by telephone by 5pm;
 - (a) on the fourteenth day in the case of a reduced penalty charge where the notice was issued under Regulation 9 of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007(a) beginning on the date the notice was served; or
 - (b) on the twenty-first day in the case of a reduced penalty charge where the notice was issued under Regulation 10 of those Regulations beginning on the date the notice was served; or
 - (c) on the twenty-eighth day in the case of a penalty charge, beginning on the date the notice was served:-

Provided that, if the said fourteenth, twenty-first or twenty-eighth day falls upon a day on which the said Department or agents' offices are closed, the period within which payment of the said charge shall be made to the Council or Council's agents shall be extended until 5pm on the next full day on which the said offices are open.

Alteration of position of a vehicle in a parking place

9. Where any vehicle is standing in a parking place in contravention of the provisions of Article 14 of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Removal of a vehicle from a parking place

10. Where a civil enforcement officer is of the opinion that any of the provisions contained in Article 13 or Article 17(2) of this Order have been contravened or not complied with in respect of a vehicle left in a parking place he may remove or cause to be removed the vehicle from the parking place and, where it is so removed, shall provide for the safe custody of the vehicle.

Movement of a vehicle in a parking place in an emergency

11. A police officer in uniform, a traffic warden or a civil enforcement officer may move or cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in a parking place.

PART III SUPPLEMENTARY PROVISIONS

Restrictions on the removal of notices

12. Where a notice has been attached to a vehicle in accordance with the provisions of Article 7 of this Order, no person, not being the driver of the vehicle, a police constable in uniform, a traffic warden or a civil enforcement officer shall remove the notice from the vehicle unless authorised to do so by the driver:

Provided that nothing herein shall apply to a traffic warden, civil enforcement officer, police constable in uniform or person removing the vehicle in pursuance of an arrangement made by a police constable by or under the regulations in pursuance of powers contained in Sections 99, 100, 101, 102, 104, 105 and 106 of the Road Traffic Regulation Act 1984.

Interval before a vehicle may again be left in a parking place

13. No vehicle which has been taken away from a parking space in a parking place referred to in any Schedule, the number of which is given in column 2 of an item in the following table, shall until the expiration of the no return period commencing at the time it was taken away again be left in the said parking place during the permitted hours, where the expression "no return period" means the interval specified in column 3 of the said item in the said table.

Manner of standing in a parking place

- 14. Every vehicle left in a parking place in accordance with the foregoing provisions of this Order shall so stand:
 - (a) in the case of a parking place in relation to which special provisions as to the manner of standing of a vehicle in that parking place are specified in column 5 of the Schedules accordance with those provisions;
 - (b) in the case of any other parking place
 - (i) if the parking place is not in a one-way street, that the left or near-side of the vehicle is adjacent to the left-hand edge of the carriageway;
 - (ii) if the parking place is in a one-way street, that the left or near-side of the vehicle is adjacent to the left-hand edge of the carriageway or that the right or off-side of the vehicle is adjacent to the right-hand edge of the carriageway;
 - (iii) that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more that 300 millimetres; and
 - (c) that every part of the vehicle is within the limits of a parking space.

Power to suspend the use of a parking place

- 15. (1) Any person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary:
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation adjacent to the parking place, the maintenance, improvement or reconstruction of the highway or the cleansing of gullies in or adjacent to the parking place, the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications system or the placing, maintenance or removal of any traffic sign;
 - (c) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture to or from one office or dwelling house adjacent to the parking place from or to a depository, another office or dwelling house;
 - (d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or

- (e) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions; or
- (f) for the purposes of filming on or adjacent to the highway.
- (2) A police officer in uniform may suspend for not longer than seven days the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (3) Any person or police officer suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1), or, as the case may be, of paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to any part of that parking place and the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited;
- (4) No person shall cause or permit a vehicle to wait in any part of a parking place during such period as there is in or adjacent to that part of the parking place a traffic sign placed in pursuance of paragraph (3) of this Article:

Provided that nothing in this paragraph shall apply –

- (i) in respect of any vehicle being used for fire brigade, ambulance or police purposes or any vehicle which is waiting for any reason specified in Article 17(1)(a), (c) and (d) of this Order; or
- (ii) to anything done with the permission of the person suspending the use of the parking place or part thereof in pursuance of paragraph (1) or paragraph (2) of this Article, a police officer in uniform, a traffic warden or a civil enforcement officer.

Restriction on the use of a parking place

16. During the permitted hours no person shall use any parking place or any vehicle while it is in a parking place in connection with the sale or offering or exposing for sale of any goods to any person in or near the parking place or in connection with the selling or offering for sale of his skill in handicraft or his services in any other capacity.

Restriction on waiting by a vehicle in a parking place

- 17. (1) Notwithstanding the foregoing provisions of this Order any vehicle may wait during the permitted hours anywhere in any part of a parking place if the use of that part has not been suspended and if:
 - (a) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;

- (b) the vehicle is being used for fire brigade, ambulance or police purposes or, not being a passenger vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
- (c) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
- (d) the vehicle is waiting:
 - (i) while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle or, having been unloaded therefrom, are being delivered; or
 - (ii) while postal packets are being collected for loading on the vehicle from premises or posting boxes adjacent to the parking place in which the vehicle is waiting or, having been so collected, are being loaded thereon;
- (e) the vehicle not being a passenger vehicle is waiting only for so long as may be reasonably necessary to enable it to be used for any purpose specified in Article 14(1)(b) of this Order;
- (f) the vehicle is in actual use in connection with the removal of furniture to or from one office or dwelling house adjacent to the parking place from or to a depository, another office or dwelling house;
- (g) in any other case the vehicle is waiting for the purpose of delivering or collecting goods or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting and the vehicle does not wait for a period exceeding twenty minutes or for such longer period as a civil enforcement officer may approve.
- (2) Except as provided by this Order, the driver or person in charge of a vehicle shall not cause or permit a vehicle to wait in a parking place during the permitted hours.

Manner of waiting in a parking place

- 18. No person shall cause or permit a vehicle to wait in a parking place by virtue of the provisions of paragraph (1)(d), (e), (f) or (g) of the last preceding Article otherwise than:
 - (a) in the case of a parking place in relation to which special provisions as to the manner of standing of a vehicle in that parking place are specified in Column 5 of the Schedules to this Order so that the vehicle shall stand:

- (i) unless the length of the vehicle precludes compliance with this subparagraph, in accordance with those provisions and so that every part of the vehicle is within the limits of the parking place; or
- (ii) if the length of the vehicle does preclude compliance with the last preceding sub-paragraph so that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than 300 millimetres; and
- (b) in the case of any other parking place, so that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than 300 millimetres; and
- (c) so that no part of the vehicle obstructs any vehicular means of ingress to or egress from any premises adjacent to the side of the road on which the vehicle is waiting.

For the purposes of the last foregoing sub-paragraph, the expression "premises" shall not include any premises to or from which any furniture is being removed by virtue of the provisions of paragraph (1)(g) of the last preceding Article or to or from which goods are being delivered or collected by virtue of the provisions of paragraph (1)(h) of that Article.

Placing of traffic signs, etc.

- 19. The Council shall:
 - (a) place and maintain traffic signs of any size, colour and type authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating the limit of each parking place; and
 - (b) place and maintain in or in the vicinity of each parking place referred to in the Schedules traffic signs of any size, colour and type prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Article 5 of this Order; and
 - (c) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a parking place.

The opportunity has been taken to make some minor amendments to the text of the Order as a consequence of the coming into force of Part 6 of the Traffic Management Act 2004.

STATEMENT OF REASONS

Broomfield Road, Kew

The changes to the on-street parking places are being altered as part of a review of the waiting restrictions and parking provision in the vicinity of the Broomfield House School. These changes are intended to rationalise the free parking provision in Broomfield Road and will be of benefit to visitors to the area and to parents of pupils attending the school.

Consolidation

- 5. The general effect of the **Kew Parking Places Order** will be to convert a parking place in Princes Road, Kew to a parking place for permit holders only (and specified in Schedule 3, item 3).
- 6. The general effect of the **Richmond Town Parking Places Order** will be to alter ten parking meter bays in Sheen Park, Richmond into parking places for residents' parking permit holders only (space for 6 cars overall) or into pay and display parking bays only, with a maximum stay of 2 hours (space for 4 cars overall), as specified in Schedule 4.
- 7. The general effect of the **Richmond Hill Parking Places Order** will be to alter two parking bays for permit holders only in Nightingale Lane, Richmond to a parking place for the shared use of permit holders and pay and display parking with a maximum stay of 4 hours, and to extend the length of the parking place, as specified in Schedule 5.
- 8. The orders referred to in paragraphs 4, 6 and 7 above will also consolidate the previous orders in respect of the relevant parking places into new orders as a matter of administrative convenience, and these, together with the order mentioned in paragraph 3 above will include minor textual alterations as a consequence of the coming into force of Part 6 of the Traffic Management Act 2004.
- 9. The proposals in respect of a new a free time-limited parking place in Kew Green, Kew, of which notice was given on 7 March 2008, are subject to further consideration by the Council.
- 10. The proposals in respect of waiting restrictions in Langham House Close, Ham, of which notice was given on 7 March 2008, have been withdrawn (see Schedule 1, item 1).
- 11. Copies of the Orders, which will come into operation on 28 July 2008, plans showing the location and effect of the Order and the Council's Statement of Reasons for making the Order can be inspected for a period of six weeks from the date of this Notice, guoting Reference 66/08, at:-

- (f) the Civic Centre (Second Floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays.
- 12. Copies of these Orders may be purchased from the Environment Directorate, Civic Centre, 44 York Street, Twickenham TW1 3BZ.
- 13. Persons wishing to question the validity of these Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.

SCHEDULE 1

Waiting restrictions "no waiting at any time", other than for item 5(b)

13 Langham House Close, Ham:

The proposals in respect of waiting restrictions in the turning head outside Nos 19 to 24 Langham House Close have been withdrawn.

14 Melliss Avenue, Kew (that part which is public highway):

Both sides at its junction with Townmead Road.

15 Mill Hill Road, Barnes:

Both sides of Mill Hill Road between its junction with Station Road / Cedars Road and Rocks Lane.

16 Mowbray Road, Ham:

The north-east side (odd house numbers), the full length. These differ from the restrictions as proposed on 7 March 2008 following local consultation.

See also the restrictions as described in item 6 below.

- 17 Townmead Road, Kew:
 - (a) the whole of Townmead Road from Mortlake Road to the Civic Amenity site "no waiting at any time"; and
 - (b) in the south-west side of the cul-de-sac section adjoining the Mortlake Crematorium "no waiting on Mondays to Fridays between 8am and 4.30pm".
- 18 At the junction of Ashburnham Road with Mowbray Road, Ham:
 - (a) on the south-east side of Ashburnham Road and on the south-west side of Mowbray Road, Ham, for distances of between 9 and 15 metres; and
 - (b) in Mowbray Road, the north-east side, as described in paragraph 4 above.
- 19 At the junction of Cedars Road with Mill Hill Road, Barnes:

On both sides of Cedars Road, for distances of between 10 and 12 metres.

- 20 At the junction of Ham Common with Langham House Close, Ham:
 On the south-west side of Ham Common and on the both sides of Langham House Close, for distances of 10 metres.
- 21 At the junction of Lower Richmond Road with Rosemary Lane and Langdon Place, Mortlake:-
 - (a) on the south side of Lower Richmond Road and the north-east side of Rosemary Lane, for distances of between 8 and 12 metres;
 - (b) on the south-west side of Rosemary Lane, from Lower Richmond Road to a point 5 metres beyond its junction with Langdon Place; and
 - (c) on both sides of Langdon Place from its junction with Rosemary Lane to the corner by No 1 Langdon Place, and for a distance of 5 metres from the corner outside No 1 Langdon Place (one side only).
- At the junction of Petersham Road, Richmond with Tree Close, Petersham:
 In the access road serving Nos 155 and 155A Petersham Road, the whole perimeter of the island site and on the north and south sides from Petersham Road to Tree Close.
- At the junction of Rocks Lane with Mill Hill Road, Barnes:
 On the west side of Rocks Lane, for distances of between 10 and 15 metres.

Changes to school clearway zig-zag markings ("no stopping" during the hours indicated)

3 Broomfield Road, Kew:

Remove the existing school keep clear marking outside Broomfield House School and in its place introduce a free parking bay as specified in Schedule 4.

4 Sheen Lane, Richmond:

Extend the existing school keep clear zig-zag markings outside Tower House School (Nos 186-190 Sheen Lane) by a distance of 6 metres giving an overall length of 30.5 metres, and which operate between 8-9.30am and between 2.30-5pm on Mondays to Fridays inclusive.

SCHEDULE 3

Changes to parking places in the Kew controlled parking zone (hours of control are Mondays to Fridays inclusive between 10am and 12 noon)

- 4 Broomfield Road, Kew, the north side:
 - To the west of its junction with Princes Way, alter the existing free time-limited parking place (space for six vehicles) from one which operates on Mondays to Fridays inclusive between 8-9.30am, between 11.45am-12.15pm and between 2.15-4.00pm allowing maximum stay of 20 minutes to one which operates during CPZ hours allowing maximum stay of 1 hour.
- Broomfield Road, Kew, the north side:
 To the east of its junction with Princes Way, introduce (in place of a school clearway which is being revoked) a free time-limited parking place (space for six vehicles) which operates during CPZ hours allowing maximum stay of 1 hour.
- 6 Princes Road, Kew, the north-west side:

Outside the flank wall of No 11 Broomfield Road and Nos 2 and 2A Princes Road, alter the two existing parking bays (with overall space for four vehicles) from free time-limited parking allowing a maximum stay of 1 hour during CPZ hours to a permit holder only bay.

SCHEDULE 4

Changes to parking places in the Richmond Town controlled parking zone (hours of control are Mondays to Saturdays inclusive between 8.30am and 6.30pm)

Sheen Park, Richmond:

- (a) changes a total of 6 parking bays, currently used as meter parking bays with a maximum stay of 4 hours and where vehicles which display a valid residents' or residents visitors permit may park between 8.30-9.30am and between 5.30-6.30pm, into parking spaces for the sole use of vehicles which display a valid residents' or residents visitors permit;
- (b) changes a total of 2 parking bays, currently used as meter parking bays with a maximum stay of 2 hours and where vehicles which display a valid residents' or residents visitors permit may park between 8.30-9.30am and between 5.30-6.30pm, into parking spaces for the sole use of vehicles which display a valid residents' or residents visitors permit; and
- (c) changes a total of 2 parking bays, currently used as meter parking bays with a maximum stay of 2 hours and where vehicles which display a valid residents' or residents visitors permit may park between 8.30-9.30am and between 5.30-6.30pm, into pay and display parking bays with a maximum stay of 2 hours.

SCHEDULE 5

Changes to parking places in the Richmond Hill controlled parking zone (hours of control are Mondays to Saturdays inclusive between 8.30am and 6.30pm)

Nightingale Lane, Richmond, the south-east side:

Alter the two existing parking bays (for permit holders only and with space for eight vehicles) to shared-use parking bays (permit holders and pay and display ticket parking with a maximum stay of 4 hours), and extend and merge them into one parking place with space for 12 vehicles, having an overall length of 61.5 metres (starting at a point 21 metres from its junction with Richmond Hill).
