**Teddington Community Parking Zone (Zone T) – (Udney Park Road area)
IMPLEMENTATION NOTICE**

We wrote to you recently to advise you of the Council's decision to extend the Teddington Zone T into the in the northern section of Udney Park Road (From High Street up to but not including Fullerton Court and Braver Court. See plan enclosed). Zone T operates Monday to Friday 8.30am to 10.30am (Except Bank and Public Holidays).

The start date will be **Monday 11 February 2019**.

Implementation works

Lining and signing works will commence this month. There may be a need to apply some parking suspensions to facilitate the lining works. However, we will endeavour to keep these parking suspensions, along with the amount of signage required, to a minimum.

In the event of a vehicle being relocated, a Penalty Charge Notice will be issued for procedural purposes but this will not carry a charge. Your co-operation is appreciated whilst these works are carried out.

Applying for parking permits

Within the zone, residents / businesses can apply for parking permits for their vehicle(s), unless a Section106 Planning Agreement applies which will either restrict or prohibit the issue of permits. Only residents may apply for resident visitor permits for their visitors' vehicles. These permits will be valid throughout **Zone T** as stated on the permit. All permits obtained will be charged for from **1st March 2019**. However, your permit will be valid and needs to be displayed from **11 February 2019**.

Residents

- Two resident permit application forms and guidance notes
- One resident visitor application form and guidance notes (Scratchcards)
- One pay by phone resident visitor application form and guidance notes

You can only apply for EITHER 'scratchcard' resident visitor permits OR 'pay by phone' resident visitor permits, not both.

Businesses

From **Monday 11 February 2019** to **2 March 2019** any parking contraventions such as parking without a permit may result in warning notices being affixed to vehicles, but there will be no further action taken. Please be advised that, from **Monday 4 March 2019**, Penalty Charge Notices could be issued.

This extension will be implemented by way of Experimental Traffic Management Orders to provide a period of operational experience of the scheme and will be monitored during the first six months of operation. We would invite you to tell us how the scheme has worked for you during this period. A full review of Zone T will also be undertaken in the coming year during which representations can be made.
