Parking consultation results: Teddington / Strawberry Hill area

From January to March 2020, the Council carried out a wide review of parking in the Teddington/Strawberry Hill areas.

Feedback was sought from residents and businesses in the yellow area shown on the enclosed map on whether they would like to see a Controlled Parking Zone (CPZ) introduced. At the same time, the Council has been reviewing all existing zones in the area to see if any changes were warranted. A summary of the responses to the key questions is shown on the enclosed pages 'Parking Consultation Results'.

Roads currently without CPZs

- To recommend a CPZ, we try to form a network or cluster of a minimum of two
 interconnected roads, with a net response in favour of a CPZ of 51% or
 over. We also look for a minimum response rate of approximately 30% over
 this network of roads.
- To add one road to an existing CPZ, we ask that a majority of respondents in that road support the CPZ.
- The results show a good response rate and high levels of support for a CPZ in several parts of the area. It looks likely that we will be able to form new CPZs and extend existing ones. We will need to consider roads and groups of roads which meet the above criteria and form coherent networks on the ground but also look at the most appropriate operational times, taking into account the responses received and the arrangements in adjacent zones etc.
- You should be aware that the final CPZs may or may not include all the roads, where 50% or more of respondents were in favour of a CPZ (listed under Q5 in the results). This is because, whilst some roads may show support on their own, they may not be connected to others and so we are unable to form them into viable networks. Similarly, it is possible that a small number of roads will be included which did not show the support on their own, because the roads around them did support the CPZ.
- Please also note that the final CPZs may not operate at the days / hours listed.
 This will also be subject to further analysis.

Existing CPZs

- Most areas prefer to retain the existing operational days / hours but Vicarage Road and Ferry Road would like to see increased operational times including on bank holidays.
- The areas which did not support increased days / hours need to be considered in light of proposals for changes in the wider area.
- A number of specific concerns were also raised from existing CPZ areas.

Next steps

We will discuss the results with your ward councillors and will write to you again with firm proposals.

Response rate

8097 questionnaires delivered. 2992 returned / completed. Response rate: 37%

Q5. To what extent do you agree or disagree that a CPZ should be implemented in your area?

2966 responded to this question. Over the whole area, 1219 supported a CPZ (41%) 1539 (52%) did not.

Q9. If a CPZ were implemented, what days would you prefer it to be in operation? 2578 responded to this question. Over the whole area, the most popular days were Monday to Friday, 2030 (79%)

Q10. If a CPZ were implemented, what hours would you prefer it to be in operation? 2516 responded to this question. Over the whole area, the most popular hours were 10am to Noon, 1053 (42%)

921 questionnaires delivered. 345 returned / completed. Response rate: 37%

Q5. Would you prefer to retain the CPZ's existing operational days/hours or change them? (Existing days/hours are Monday to Friday, 8.30am to 10.30am) 332 responded to this question. 191 (58%) Retain existing days/hours, 141 (42%) Change hours/days

Q7 What days do you think the CPZ should operate?

341 responded to this question. 230 (67%) Retain Mon-Fri, 72 (21%) Mon-Sat, 39 (11%) Mon-Sun

Q8 What hours do you think the CPZ should operate?

337 responded to this question. 197 (58%) Retain existing hours

Christchurch Avenue & Nos. 1-9 Station Rd (Zone T)

(Existing days/hours are 8.30am to 10pm, Mon to Sat (excluding bank holidays). 63% want to retain the existing days/hours

Waldegrave Rd (Zone T)

(Existing days/hours are Monday to Friday, 10.00am to 4.30pm)

71% want to retain existing days, 38%* want to retain existing hours (*This represents the highest number of responses)

Elleray Road (Z1)

Existing days/hours are 8.30am to 10pm, Monday to Sunday, including bank holidays 95% want to retain existing hrs/days

Ferry Road (Z2)

Existing hours/days are 8.30am to 6.30pm, Monday to Sunday excluding bank holidays) 57% want 8.30am to 10pm, 86% want Mon-Sun, 86% want inclusion of bank holidays

Southfield Gardens (Z4)

Existing days/hours are Monday to Friday, 10.30am to 2.30pm 95% want to retain existing days. 85% want to retain existing hours.

Vicarage Road (M1)

Existing days/hours are 8.30am to 6.30pm, Monday to Sunday, excluding bank holidays 88% want to change hrs

88% want 8.30am to 10pm, 88% want Mon-Sun, 71% want to include bank holidays
