## South West Twickenham Controlled Parking Zone – DECISION NOTIFICATION LETTER

We last wrote to you in June 2021 with the final scheme design of the South West Twickenham Controlled Parking Zone (CPZ), information about the formal consultation process, which ran from 24 June to 16 July, and how to make representations.

A summary of the outcome of the formal consultation process is below:

## THE RESULTS SHOW:

- 67 surveys/questionnaires were completed. Of this number, 29 respondents support the proposals, 33 oppose the proposals with 5 expressing no view.
- 29 e-mails/letters were received. Of this number, three respondents support the proposals, 14 oppose some or all of the proposals with twelve expressing no view or making general comments.
- In total, 32 respondents made representations supporting the CPZ with 47 respondents making representations opposing the CPZ in part or fully.

## **DECISION:**

In considering all of the factors, the original consultation results, amendments made to the design (including the reductions of certain yellow lines), and the representations, it was agreed that:

- The South-West Twickenham CPZ will be implemented to operate Monday to Friday 10am to 4.30pm to include all roads as advertised with final minor amendments to the scheme layout as appropriate.
- The scheme will be subject to a review after six months of operation in line with the Council's CPZ policy.

The outcome of this process formed part of a report which featured the main issues raised by respondents and how they were considered by officers.

The implementation of the CPZ is expected to improve parking conditions in the area by removing parking by non-residents and time will need to be allowed for the scheme to settle down. As stated earlier in this letter, it will be reviewed after six months of operation.

We are aiming to bring the new CPZ into operation in March/April 2022 and preparations are now underway to do this. This will involve the installation of the appropriate signs and lining, expected to commence in February. Whilst we will endeavour to minimise the disruption caused during the implementation works, there will be a need to temporarily suspend some parking. This will enable the works to be executed as safely and as efficiently as possible.

We will write to you again to confirm the start date of the CPZ along with guidance on how to apply for a parking permit.
