#### **OUR PROPOSAL**

The Richmond Food Partnership (RFP) will be based on three principles:

- Sustainable reduce the climate and environmental impact of food
- 2. Healthy nutritious and healthy diets
- 3. Affordable reduce food costs

The RFP will enable access to sustainable, healthy, and affordable food for all





#### WHY?

#### The Cost of Living Crisis

- Average cost of food and non-alcoholic drinks increased by 16.2% between October 2021 and October 2022
- Highest rate of food price rises since 1977
- Over 93% of food banks have reported a rise in demand

#### **Climate Change and Environment**

- 9.5 million tonnes of food was wasted in the UK in 2018 = £19 billion a year and 36 million tonnes of greenhouse gas emissions
- In the UK, dietary greenhouse gas emissions are roughly twice as high for meat eaters than vegans


#### Health

- Adults: 25.9 % are obese and 37.9% are overweight in England
- Children: 23.4% of 10-11 year olds are obese and 14.3% are overweight in England
- Prevalence of excess weight (obesity and overweight) is higher in the most deprived areas in England
- Children in the most deprived areas of England are twice as likely to be obese and four times as likely to be severely obese compared with children in the least deprived areas



#### THE CO-BENEFITS

E.g., reducing red meat consumption reduces greenhouse gas emissions and associated health risks (such as high cholesterol, heart disease, and cancers)



E.g., reducing food waste reduces greenhouse gas emissions from landfill and saves money by not wasting money on uneaten food

E.g., people living in more deprived areas tend to have less healthy diets and higher rates of obesity (calory for calory, unhealthy, processed foods are cheaper) – these challenges can be addressed together





#### THE RFP IN PRACTICE

- Cost of Living Crisis will be central to the RFP, helping address the urgent need for many people to access food
- The RFP will build out from a central focus
  of affordable food for all to ensure this
  food is also sustainable and healthy
- The co-benefits will be maximised to ensure the RFP runs as efficiently and effectively as possible
- The RFP will be voluntary-sector led, with support from the council



## CASE STUDY ISLINGTON FOOD PARTNERSHIP

- "A broad coalition of local organisations and individuals working together to develop an ambitious and sustainable food network for Islington"
- What it does for **local residents**:
  - Gives information on local community food services
  - Gives opportunities to influence local food strategies and services

- What it does for **partner organisations**:
  - Collaborates on funding bids and fundraising initiatives
  - Gathers and shares data and information on food across the Borough
  - Designs and works together on projects and ideas
  - Shares expertise and good practice
  - Works together to help shape and influence local and national food policies



#### SUPPORTING THE VOLUNTARY SECTOR

- Identifying and maximising links between voluntary sector organisations
- Managing the demands around affordable food
- Broader coordination across the borough on food issues
- Funding support and identifying opportunities for funding
- Maximising and increasing the impact of interventions by working as part of a broader collaboration
- Sharing of information, expertise and best practice
- Collaborative working to influence local and national food policies




- CREW is a SW not for profit community group.

- We have experience of installing solar PV, battery storage, EV charging, heat pumps, LED lighting, smart heating controls and heat transfer solutions.
- We have a community outreach team that helps people with energy advice and behavioural change.

## Why are we in this crisis?



- ► Long term gas price is just 50p
- Prices rose before war due to Asia's decarbonisation from coal to gas
- Expect price swings every time Asia has a cold winter.
- ► Lack of UK storage makes us vulnerable

### Long term price-long term problem



### **Government Support**

- Prices capped until April
  - ► Electricity at 21.1p per KWh wholesale price. Delivered price around 30p
  - ► Gas at 7.5p per kWh whole price, delivered price around 10p
- From April the Government will introduce the Energy Bills Discount Scheme for one year
  - ➤ Support will only kick in if electricity prices breach 30.2p per kWh and gas prices at 10.7p per kWh.
  - ► Maximum price support will be 19.61p and 6.97p respectively
- ► Government support will need to be refunded over time so extending the period of high prices.

## **Step 1: Easy Wins**

#### Behavioural change

- ► Reduce standy by time and switch off computers and printers at night
  - Typical computer use 5 w per hour in sleep mode and 100 w when in use
  - ► Save £10 per year on standby, £200 in full energy mode
- ► Optimise brightness of monitors
  - ► A reduction for 100% to 70% can cut energy usage by 20%
- ► Last person turns off the lights at night or install microwave sensors
  - ➤ 20 twin T8 tubes left on for 12 hours overnight would cost £8.06 per night
- ► Reduce the flow temperature of your boiler to improve efficiency.
- Fix draughts, don't plug in additional heaters.
  - ► Each fan heater now costs 60p per hour or £ 4.8 per day.
- ► Staff kitchen, air handling, heavy machinery.

### **Step 2: Affordable Wins**

► Technologies that are affordable but will have a big impact on your emissions and will pay back quickly

Technology	Payback
LED lighting	1-3 years
Smart building controls	2-4 years
Loft insulation	3-5 years
Hydromx heat transfer solution	2-4 years

### **Step 3: Larger Investments**

#### Solar Panels

- ► Visual evidence of your green credentials
- ► High energy prices ensure shorter paybacks
- ► Decoupling from energy inflation
- ► Potential for 3rd party funding

#### Heat Pumps

- ► Perhaps the biggest carbon reduction
- Currently £5000 subsidy from UK Government
- ► Gas prices outstriping power prices
- ► Heat pumps currently 2.3p cheaper per kWh than a gas boiler
- ► Reduced maintenance cost

▶ 130% Super Deduction allowance rebate runs until April 2023

## **Energy Contracts, Brokers and Measurement**

- ► Are you on a fixed price contract?
  - ► Ideally contract as long as possible
  - ► Retail vs. Wholesale prices
    - ► Retail, little opportunity to negotiate
    - ► Wholesale...can negotiate, access to longer contracts
  - ► Energy Brokers can give access to wholesale market via a portfolio / basket approach
  - ► Fix in April or October
  - ► Crew use Utility Aid
- Measurement
  - ► Do you understand you energy bills?
  - ▶ Do you have smart meters / access to intraday data?
  - ► Analyse these for anomalies









# Pre-event survey: Is Cost of Living impacting on clients? — 100% yes




# Do you know where to refer people when they need support you cannot offer?
