CONTROLLED PARKING ZONE B EXTENSION

(Reference 24/042)

1. The Council of the London Borough of Richmond upon Thames propose to make the above Orders under sections 6, 45, 46 and 49 of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the **Parking Places Order** will be to extend the Zone B Controlled Parking Zone to Arundel Terrace, Glenthams Road, Glenthams Gardens, Lillian Road, Merthyr Terrace and St Hilda's Road. The zone will operate between 10am and 6.30pm on Mondays to Fridays inclusive.
3. The general effect of the **Parking Places Supplementary Provisions Permits Order** will be to set the charges for parking permits as described in Schedule 1 to this Notice.
4. The general effect of the On Street **Parking Places Parking Charges Order** will be to set the RingGo cashless parking charges as described in Schedule 2 to this Notice.
5. The general effect of the **Waiting and Loading Restriction Order** will be to introduce waiting restrictions in various lengths of the roads within the zone operating at any time and between 10am and 6.30pm on Mondays to Fridays inclusive.
6. Within the zone, there will be designated permit holder only parking places where only vehicles which display a valid resident's permit, a valid business permit, a residents' visitor permit, a multi-zone business permit or an operational permit may park during the controlled hours. There will also be designated spaces where parking will be permitted upon payment of the appropriate charge.

 - (a) can be inspected, quoting Reference 24/0/42, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
