- The certificate becomes operative on the date on which this notice is first published. A person aggrieved by the certificate may, by application to the High Court within 6 weeks from that date, challenge its validity on the ground that there has been a failure to comply with any relevant statutory requirement relating to the certificate.

## **DESCRIPTION OF THE NEW RIGHTS**

The new rights to be purchased compulsorily over land described above and shaded blue on the order map which will comprise crane oversailing during the construction period; rights of access on to adjacent land during the construction period; rights to erect scaffolding/scaffolding fans/hoarding; right to conduct work to party walls during the construction period; and the right to lay, repair, use and maintain new and existing services.
