Fulwell Park Estate, Twickenham – Reinstatement of footway parking areas and new double yellow lines

In April the Council contacted residents of the Counties and Fulwell Park Estates to advise of the reinstatement of the marked footway parking areas and the implementation of new lengths of double yellow lines.

In response to requests from some residents during the consultation, and in light of an ongoing review of how non-compliant vehicular crossovers should be treated in the future, it was decided not to reinstate line markings of existing parking bays in front of these crossovers. This was to allow for more clarity to be sought about potential policy changes (now envisaged to be discussed by the relevant decision-making Committee in October). The Council accepts that this decision was not properly communicated to residents.

However, postponing the marking of parking bays at these locations resulted in more complaints from residents of the Counties and Fulwell Park Estates about the treatment of non-compliant crossovers, suggesting that this had also created confusion about where parking on street is permitted.

This has compelled the Council to act in line with the existing policy and so we are unable to continue with this approach. Therefore, non-compliant crossovers will be treated the same as other viable parking locations and the scheme will now be delivered as was originally consulted in April. This work is expected to be undertaken by the Autumn.

If you have a non-compliant crossover and wish to use your hard standing for parking, you will need to apply for a dropped kerb. The Council can then consider your application to ensure it meets the appropriate criteria. If it does meet the criteria, the bay markings will be removed during the construction phase. New lengths of double yellow lines

Double yellow lines that were implemented on road safety grounds will remain unchanged and become operational from **Monday 11 September**.

From **Monday 11 September to Sunday 24 September** any parking contraventions for parking on these double yellow lines may result in a warning notice being issued. From **Monday 25 September**, Penalty Charge Notices will be issued.

As advised in our April 2023 letter, the double yellow lines have been implemented with an Experimental Traffic Management Order. This will provide a statutory consultation period of six months **up to Friday 15 March 2024**, in which time representations can be made. Representations may be made either by letter to the Head of Engineering (Traffic

Some adjustments have been made to the design following early feedback from residents. In Augusta Road, between Lisbon Avenue and Staines Road the layout will revert to parking solely on the north side and double yellow lines will be installed on the south side. This follows complaints from residents concerning the congestion and reduced footway widths caused by parked commercial vehicles at this location.

Large size drawings of the measures will also be available to view at Twickenham Library, Garfield Road, Twickenham, Middlesex TW1 3JT during normal opening hours.

Other matters

The Council will be consulting all properties of this area on the possibility of introducing a controlled parking zone (CPZ), and it is intended this will take place in the New Year. This follows several comments/complaints from this and the nearby Leeson Estate (Twining Avenue, Fielding Avenue etc) area concerning the difficulties some residents are experiencing in finding a parking space near to their home. It is understood that these difficulties are due to non-residents (including commuters) parking in this area.

Please also be informed that, separate to this scheme, new lengths of double yellow lines will be implemented in Staines Road, between Fifth Cross Road and Sixth Cross Road, to primarily improve sight lines and access at road junctions. Implementation of these double yellow lines is expected to be completed in the next few weeks.
