Hi team,

Please see below and attached. It's not going to make us popular but I'm afraid I think we're going to have to open a file on this given that the matter has been brought to everyone's attention through the recent planning application refused at Committee yesterday.

From what I can see, Petersham Nurseries are currently operating in breach of two conditions on 08/4312/FUL:

 Condition NS05 - The café/restaurant areas shall be confined solely to the areas identified for these purposes on Approved Drawing Number DP7/2857 for Permission 07/1235/FUL. REASON: To safeguard the MOL, conservation area, amenities of nearby residential properties and the area generally. The approved drawing shows a very limited A3 area and from officers site visits it is clear that the café element has extended into the other two glasshouses and there are extensive further areas of outdoor seating. I'm not 100% sure, but I got the impression that the restaurant area has also expanded to take up a greater floor area within the eastern-most glasshouse. I have no idea how long it has been operating like this for.

If they want to apply for a VRC to regularise this, we're going to get into the question of whether or not this is still a genuine mixed use and the impact of the intensification of the A3 use on traffic & MOL in particular. Many of the recent objections to 14/0345/VRC have been on traffic and parking grounds due to the number of visitors in the day and the transport surveys that have submitted do show that there is overspill into River Lane in the daytime.

Condition NS04 - There shall be no sale of food for consumption on or off the premises during the following times:
 Tuesday to Sunday – before 1000hrs and after 1630hrs and on Sundays – before 1100hrs and after 1630hrs. The A3 premises shall not be open on Mondays. A notice to this effect shall be displayed at all times on the premises so as to be visible from outside. REASON: To safeguard the MOL, conservation area, amenities of nearby residential properties and the area generally.

There are two issues here. Firstly, the daytime use appears to be operating outside of these hours according to the times advertised on their website. The restaurant is open 12-5pm and the teahouse opens to 5pm too. The extra half an hour isn't a significant concern but if they want to regularise those hours with a new application we're going to need to consider to what extent we deal with the increase in the A3 use at the site at the same time.

The business has been operating evening A3 use some 12 times a year for some time. They have given the impression that this is all fine as they've sorted the licencing through Temporary Event Notices, but nonetheless are in breach of the planning condition. Craig, a response to questions may be best coming from you, or we can just say that we're opening an investigation for the time being?

The Green Travel Plan condition hasn't been discharged yet either but we do have a current application for that which Jim & I can discuss further.

At last night's Committee I did flag up publicly that we would encourage the applicant to discuss this matter with us and I've put an informative on the decision notice to 14/0345/VRC to that effect.

Dear Councillor Elengorn

Have you had a chance to look into the planning contravention at Petersham Nurseries? As background, and I have made multiple objections and complaints to the Planning Enforcement people on both this subject and night opening - going back to November 2010. Very little has been done during that time despite our continued requests.

It is a grave concern that the Nurseries Manager seems to be using the tack that they have been "operating like this for ten years" so it is Ok to ignore the planning restrictions that were originally put in place to limit the number of covers at both the restaurant and cafe. Since I last emailed you they have erected a large and very obtrusive roof cover over the outside dining area. The website says from next Monday they will be open for lunch and afternoon tea every day and dinner three times a week. Previously, the Nurseries have only been allowed to open in the evenings by applying for TENS which are restricted I believe to 12 per year.

We do understand that they wish to regain lost monies caused by the recent pandemic restrictions, however, I'm afraid that judging by past behaviour, if they are allowed to operate outside of planning regulations as a temporary measure, they will continue to do so after all restrictions are lifted.

Petersham is a very peaceful, rural, residential area. The Nurseries now attracts visitors from far and wide thanks to very skilled PR and international promotion, and is a beautifully styled restaurant and gift shop with a few plants for sale! The size and scope of the enterprise far exceeds the local infrastructure, and sadly is once again causing disruption to its neighbours and local residents and I would ask you to intercede.

Dear Councillor Elengorn

I am writing to you in your capacity as a member of the LBRUT Planning Committee with regard to Petersham Nurseries.

At a January 2018 Planning Committee meeting alongside two other residents of Petersham I spoke against an application by the Nurseries for evening opening. This application was denied, and I recall you being vociferous in your views against the Nurseries being allowed to open at night.

You were also very surprised to hear that the Nurseries had not adhered to the permitted area of use for dining granted in 2007, and in fact had doubled the area in which they serve food. Despite my husband and I protesting against this infringement of planning, the Nurseries continue to abuse the agreed area and have expanded even more since 2018.

Today my neighbour and I spoke to the Nurseries Manager, Paula Foulser. We asked what the plans are for the reopening of the cafe as it appears that additional space was going to be used for F&B. We were told that they will be using the same outdoor dining space they have used "for ten years" when they reopen on April 12th and that they are constantly talking to the Council about this. If so I sincerely hope that the Council takes action against the infringement of their Planning decision and tell the Nurseries that they can only serve F&B in the permitted areas. I attach the plan to indicate the permitted areas and the areas currently in use.

I would be very grateful for your views on what the Council plans to do to stop this planning breach. We are of course happy to see the Nurseries reopen and wish them well after a period of reduced trading. However, they should respect the planning decision and keep to the permitted dining area in order to reduce the impact on their neighbours.
