Kew Controlled Parking Zones Review

In August / September 2024, we carried out consultations with all properties in Kew concerning the operation of the controlled parking zones in the area – see map overleaf.

As planned, the results of the consultations were reported to the Council's Transport and Air Quality Committee on 3 February 2025. The Committee agreed the officer's recommendations which were:

- That the operational hours of the Kew Road parking bays be extended to 10pm and monitored/reviewed as described in paragraph 7.27 of the report
- That the Zone KC Event Zone continues to operate for when events are held in the area as described in paragraph 7.39 of the report
- That no other specific changes in zone boundaries, operational hours/days of Zones KA, KB and KC be agreed at this time but that officers develop a number of operational changes/improvements to the zones through further discussions with the ward councillors and consultation with affected frontages through delegated powers

If you responded to any of our consultations, I thank you for taking the time to make the Council aware of your views.



