The draft Local Plan refers to Richmond Station: "Its 1930 Art Deco façade and entrance/booking hall make it worthy of its BTM status, though the side and rear of the building is unattractive and is not considered to contribute to the setting" Developing buildings behind the station of 7-8 storeys runs the risk of making the facade (designed by the same architect who designed Surbiton Station which is listed) look ridiculous. The centre of Richmond is not a high rise area so anything more than the surrounding area will look out of place

However there is a significant difference between the distance travelled by a cyclist and a pedestrian. The draft Plan should be clearer as to what is meant. The point is significant because the evidence referred to states that Richmond has an ageing population. The elderly or those with mobility issues may not be physically able to walk let alone cycle

There is no acknowledgment that such persons might need to drive or be driven
